



## **MEMBERSHIP T & C's**

### **ACCEPTANCE OF TERMS**

By applying for and using a membership at the Dunes Driving Range, you acknowledge that you have read, understood, and agreed to be bound by the Dunes Driving Range Membership Terms and Conditions as outlined below, in addition to the Mount Maunganui Golf Clubs General Terms and Conditions.

These membership terms and conditions ("Terms") govern the use of the Dunes Driving Range facilities.

### **MEMBERSHIP TERM**

Membership has a minimum term of six months (Foundation Memberships) and three months (other memberships) from the date of initiation. Early termination of the membership before the completion of the minimum term may be subject to an administration fee.

### **MEMBERSHIP FEES & PRICING**

Membership fees will be charged weekly. Membership pricing details can be found on the Dunes Driving Range website.

Weekly membership fees attract a 1.9% credit card surcharge plus a 50 cent transaction software fee. (EG \$20.00 will be charged as \$20.88).

Each members membership week will run from the day their credit card is charged for 7 days.

Upfront annual membership fees are an option, please contact the Driving Range Manager for details.

### **RANGE BAY BOOKINGS**

Range Bay/Simulator bookings made whilst a member, are for the member and the member only. The member may bring a guest along to share the bay during staffed hours at fee of \$10.00 per guest.

Range Bay/Simulator bookings are not transferable to any other person. Bookings made under a members name and used by someone else will be treated as a breach of the code of conduct.

Children/s under the age of 10 may share the range bay/Simulator with the member at no charge.

Junior members under 10 years may only use the practice areas when supervised by an adult member or by member of the coaching staff. Members children between 5 and 10 years, who are themselves not members, may use the practice areas under the supervision of a member.

The Member accepts the general range bay/simulator terms and conditions for each and every booking.

### **UNUSED SESSIONS**

Unused range bay or simulator sessions do not roll over to subsequent weeks. It is the member's responsibility to utilise their allocated sessions within the respective billing week.

### **GOLF BALLS AND RANGE AREA**

Range users may not enter the range hitting area under any circumstances. Dunes Driving Range balls must not be taken away from the Dunes Driving Range.

### **EARLY TERMINATION ADMIN FEE**

If a member chooses to terminate their membership before the completion of the minimum term, an administration fee of \$125 will be charged. The administration fee is intended to cover the costs associated with processing the early termination and related administrative tasks.

### **MEMBERSHIP ACCESS**

Members have the following access to the Dunes Driving Range facility;

Monday/Tuesdays – 7.30am – 5.15pm

Wednesday – Saturday 7.30am – 8.00pm

Sundays 7.30am – 6.00pm

Public Holidays – Hours may vary

Xmas Day - CLOSED

Access may be restricted for maintenance, special events such as Exclusive Venue Hires, Leagues/tournaments or unforeseen circumstances.

## **MEMBERSHIP TERMINATION**

The Dunes Driving Range reserves the right to terminate a membership for violations of these terms or inappropriate behaviour. Termination may result from, but is not limited to, the following reasons:

- Fails to pay membership fees when due.
- Failing to follow club rules.
- Intentional damage.
- Allow access to non-members.
- Deemed serious misconduct.

## **BOOKING & CANCELLATION**

Members can book range/simulator bays in advance through the online booking system. Cancellations must be made within a reasonable time frame, as specified by the Dunes Driving Range.

## **CODE OF CONDUCT**

Members must adhere to the Mount Maunganui Golf Club Code of Conduct which is attached here.

## **DAMAGE/UPSTAIRS NETTING**

Any damage caused to equipment, the range, or other parts of the facility will be repaired or replaced at the users cost.

Please note that anyone falling into the upstairs net will require the net to be serviced at a cost of \$1400.00. If the fall into the net is deemed to be through intentional, the user will be passed on this cost.

## **PERSONAL PROPERTY**

I acknowledge that while in the facility, I am responsible for my own belongings.

## **SECURITY**

I acknowledge that for security and accept for safety, The Dunes Driving Range can use security video surveillance systems to monitor the facility 24 hours a day. Video systems are limited to the golf simulation area.

## **DISCLAIMER OF LIABILITY**

The Dunes Driving Range shall not be held liable for any loss, damage, or injury incurred by members during the use of the facility. I acknowledge that the use of The Dunes Driving Range during staffed and after hours may pose a risk of injury or harm. I confirm

that while in the facility, I will use the equipment and services at my own risk. I release and indemnify The Dunes Driving Range, its staff, servants, and agents against any and all claims relating to any injury, loss, or serious harm caused to me or my property.

Amendments: The Dunes Driving Range reserves the right to amend these terms and conditions at its discretion. Members will be notified of any significant changes, and continued use of the facility constitutes acceptance of the amended terms.
